# **Reduced Inspection & Repair Costs**

Our members noticed that repair estimate accuracy increases when depots use IICL certified inspectors.

Overall, depots using certified IICL inspectors create repair estimates with higher accuracy which in turn reduces the number of additional handlings at the depots as fewer units are selected for inspections. IICL inspectors learn how to identify damages and select the most economical repair method, potentially saving on overestimated costly repairs.

Obtaining an IICL Inspector certificate requires individuals to study and stay up to date with the latest technical manuals, technical bulletins, become familiar with ISO/CEDEX coding, and have knowledge of the proper measurement techniques developed by the IICL. It is an individual commitment to work at a high level of quality according to industry established inspection and repair standards.

#### **Ensuring the safety of handlers during Container transport**

IICL certification is an important step towards becoming compliant with the Convention for Safe Containers – CSC. The certification process provides individuals with the knowledge to help inspectors to examine containers and assess whether it has any defect which could place any person in danger.
