IICL Elects 2023 Officers

Olivier Ghesquiere was appointed President and Chief Executive Officer as well as a member of the Board of Directors of Textainer Group Holding Limited in August of 2018 after joining the company in 2016. He brings more than 30 years of international experience in transport asset management and leasing industries.

Prior to joining Textainer, Mr. Ghesquiere worked at Ermewa Group as Chief Executive Officer where he was responsible for growing the railcar and locomotive fleet to become the second largest in Europe. During that time, he was also chairman of Eurotainer SA, a leader in specialized tank container leasing. He previously held various management positions for the Brambles Group, an Australian listed supply chain logistics company.

Mr. Ghesquiere holds a degree in Applied Economics from the University of Louvain, Belgium.
