
From the IICL Studios!!!



Refrigerated Containers

The IICL and its members are working to further research and learn more about the harmful effects of refrigerated containers having the interior sprayed with chemicals. A warning bulletin followed by a Reefer Technical Bulletin - RTB 009, and one revision, have been released. We will provide further updates as more information becomes available. The best way to ensure that you are up to date is to subscribe (for free) at the IICL website to receive news and updates as they are released.

Inspector Certification Exams

IICL continues to receive interest for its inspector certification exam registrations worldwide. As of 30 September 2022, IICL certification exam registrations have increased 34% compared to 2021. We also expect a surge in registrations thru the end of the year. The recently launched exam automated results feature which posts test results to candidate transcripts within 48 hours of the exam date has been embraced by the industry as well as provided inspectors the capability to view examination results and obtain their certifications much sooner than in the past.

Automated Recertification Reminders

New to the IICL is the automated recertification reminders feature which reminds actively certified inspectors via email that their current certification is due to expire on their individual expiration date. Inspectors are also asked to schedule an exam in order to retain their current certification status and upgrade their IICL Inspector Recognition Program Star Rating. We are confident that the aforementioned features have encouraged more surveyors/container handlers to participate in the IICL Education Program by sending reminders and providing much improved post-exam resources to obtain their credentials in a timely manner.
